- 4 Any props or decorations with blood or guts are not permitted as they might scare the children.
- 5 Only hand out pre-packaged items. NO BAKERY OR FRESH FRUIT.
- 6 No drawings or raffles will be allowed on trail. It will cause heavy congestion on the trail.
- 7 You can use signs, banners or carved pumpkins to promote your business.
- 8 Most Halloween items can be used for your display - NO BLOOD AND GUTS OR GORY THINGS.
- 9 Please help us - Pick up any trash and/or candy wrappers around your site prior to leaving.
- 10 MOST IMPORTANT - HAVE FUN.
